LIVE EXPORT

Federal Labour MP for the NSW seat of Page Janelle Saffin introduced a Private Member's bill into Parliament on Monday the 21st of March. The Bill urges Australia to shift away from the live export of cattle and sheep and ship more frozen and chilled meats instead. These bills typically garner support from unions and meat processors and left leaning political organisations.
