PRODUCTIVITY COMMISSION INQUIRY – WHEAT EXPORT MARKETING ARRANGEMENTS

Rick Wilson, Leon Bradley and Janet Thompson appeared before the Productivity Commission's hearing in Perth on 3 May.

Due to grave concerns over monopolistic behaviour of the bulk handling companies, representatives of PGA encouraged another round of accreditation with WEA being extended to coincide with the 2014 deadline for port access under-takings oversight.

PRODUCTIVITY COMMISSION INQUIRY INTO RRDCS

A working group was convened on 11 May to brainstorm on a submission to the PC on rural research and development corporations, specifically GRDC. In general, producers are concerned about decreasing productivity gains relative to the levy percentage, apparent politicisation of the GRDC processes, and use of levy dollars in attempting to meet criteria for funding that is pre-determined by Government. Submissions are due on 25 June, and intense research is being conducted at this time. Details of the inquiry are available here:

Len Buckridge is willing and ready to develop the port for what would initially be bulk commodities and live export, with plans to expand into container services in stage two of the development.
