

# CATTLE COUNCIL - RISING CHAMPIONS INITIATIVE

Cattle Council is seeking applications from people aged between 21 and 35 for its Rising Champion Initiative. State finalists will travel to Canberra to share their views on the 'real-life' beef industry challenges with Cattle Council, attend tailored workshops, meet with politicians and tour Parliament House. The 2013 Rising Champion will win an all expenses paid trip to Perth to attend the MLA AGM and there is also a scholarship to Marcus Oldham College on offer courtesy of the Australian Beef Industry Foundation. Applications close midnight 21 September 2012.

#### AWI WOOLPOLL

The PGA member Mr Wayne Duffield of Darkan is Western Australia's representative to Wool Poll 2012. The panel has met to put together the WoolPoll Voter Information Kit. This kit will be sent to growers to assist them to vote to determine the rate of Wool Tax for the next three years. It should be noted that although the panel endorsed the document, it was not required and did not endorse AWI's recommended rate or specific content or its rationale for the recommendation. The panel is only required to ensure the information is presented as per the Regulations. There are five levy rate options in WoolPoll 2012 - 3% / 2.5% / 2% / 1% / 0%. Following a thorough debate at both the Livestock and Executive Committee meetings, the PGA has decided to recommend that its members vote for **no more than 1% in Wool Poll 2012.** Voting for WoolPoll 2012 opens on September 21 and closes on November 2. The Chairman encourages all wool growers to exercise their voting rights. In a recent media release he said "If you think not voting is a protest, you're wrong, you just won't count. Apathy will ensure more of the same."

## **AUSTRALIAN PEST LOCUSTS**

The EO attended the Australian Pest Locust industry briefing on behalf of the President. APL is a declared species. The last outbreak was in 2006. DAFWA will not conduct aerial spraying. The cost of aerial spraying during the last outbreak was \$13 million. DAFWA will conduct surveillance and will make an offer to coordinate local operations. The most likely location for any outbreaks will be in the South Coastal areas of Jerramungup, Ravensthorpe and the Fitzgerald River. However, the Mt Marshall area is also a traditional hot spot due to summer rainstorms. Notes on this meeting are available from the EO.
